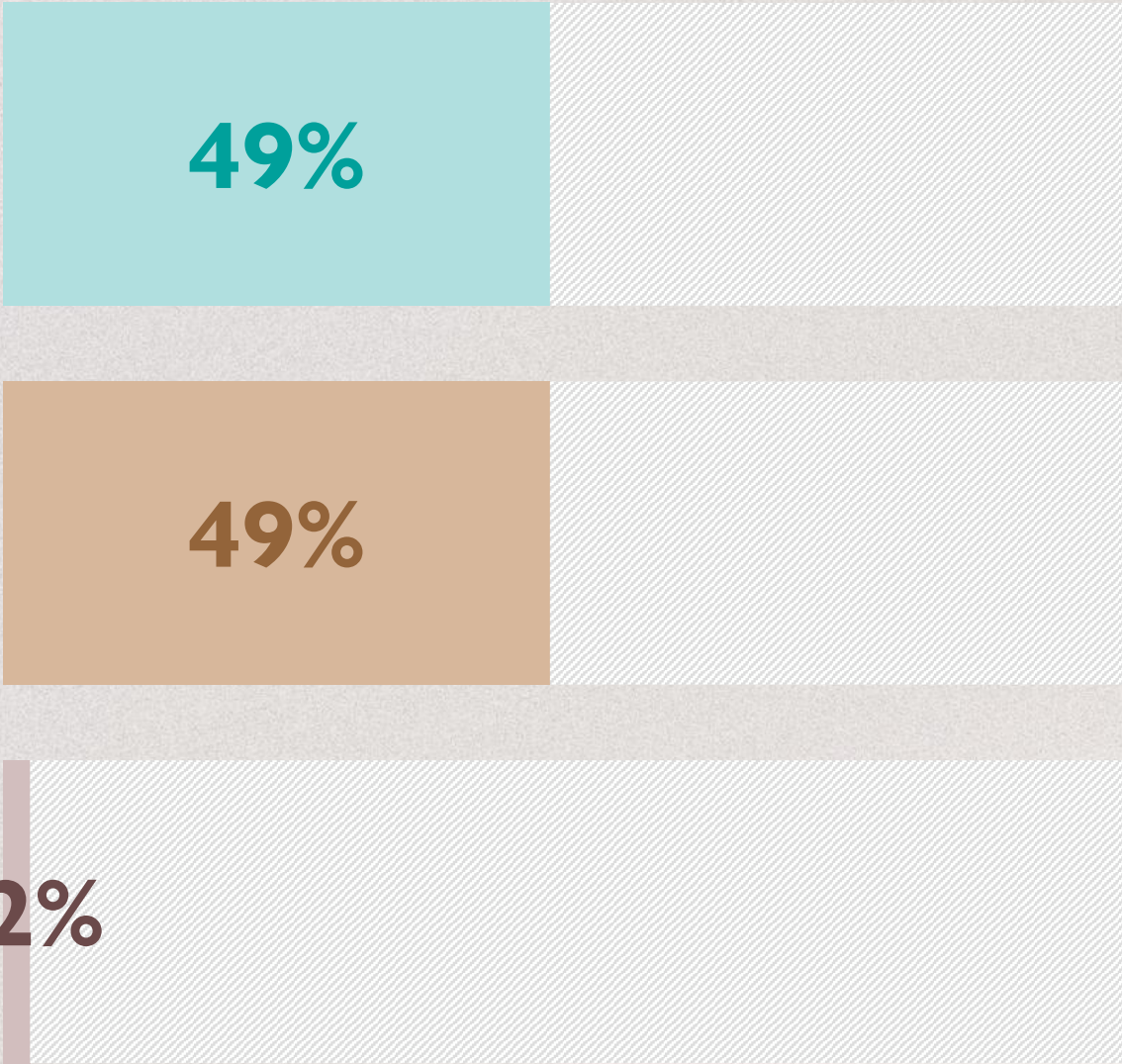

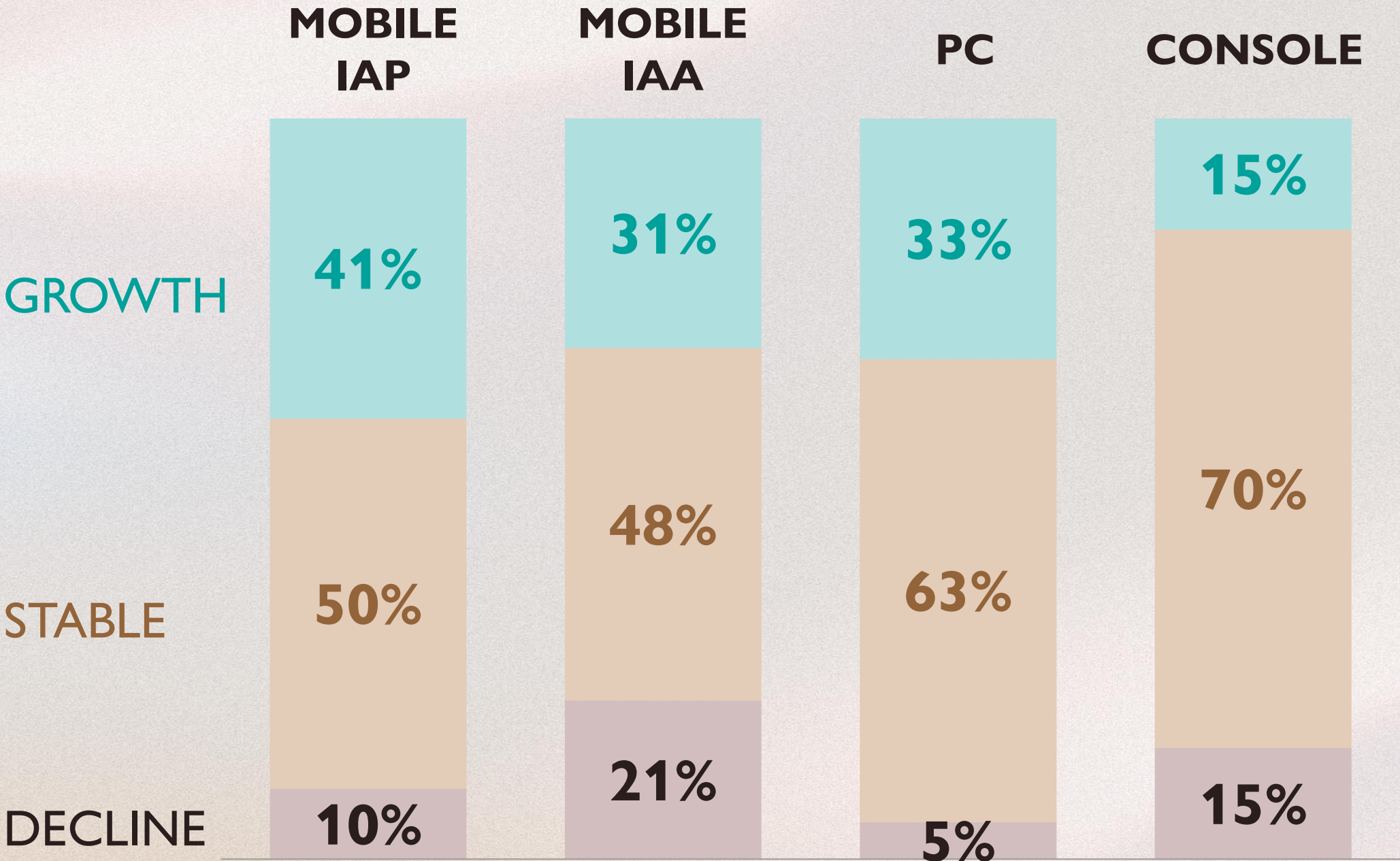

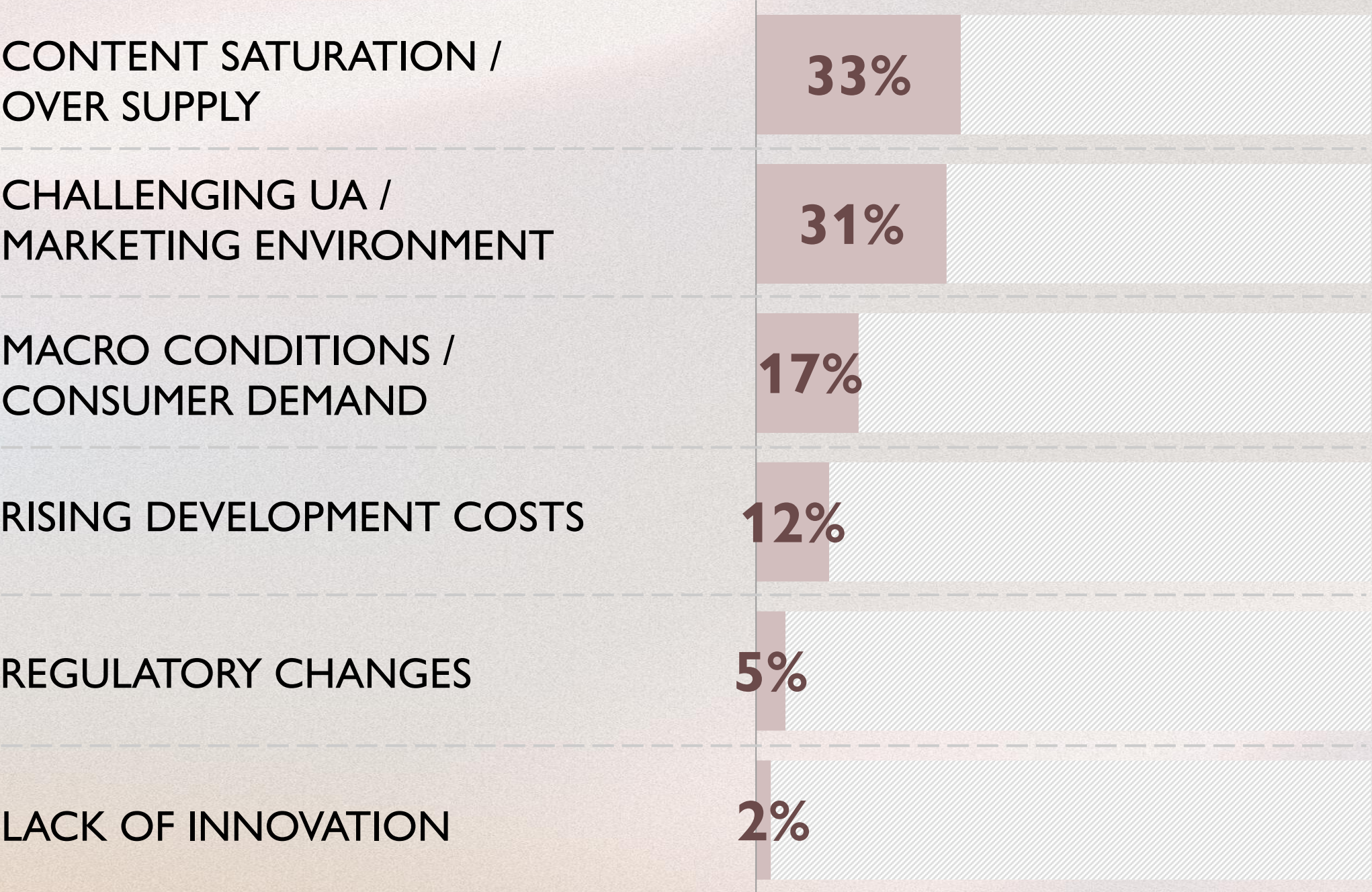

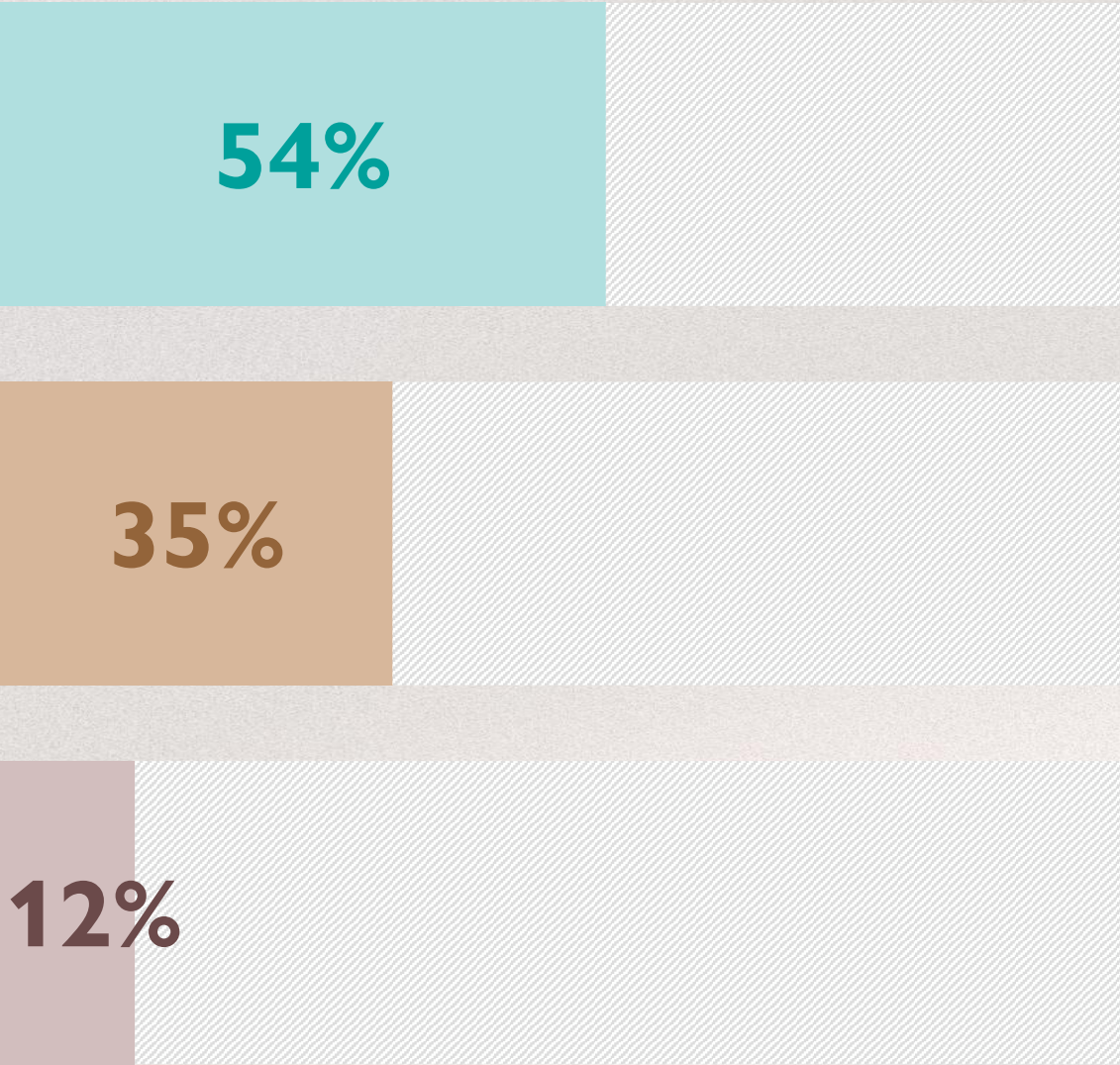

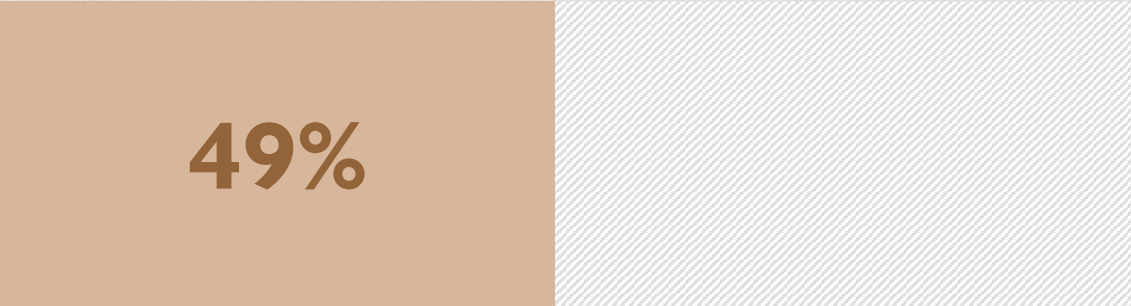

How do you anticipate your average budget per game to change in 2025 vs. 2024?

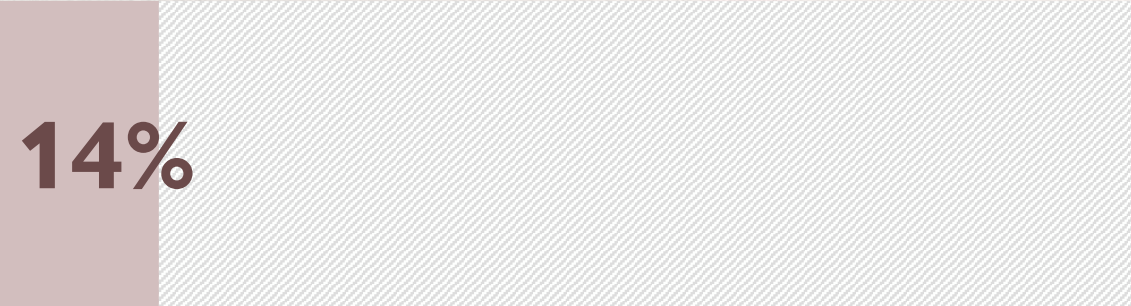

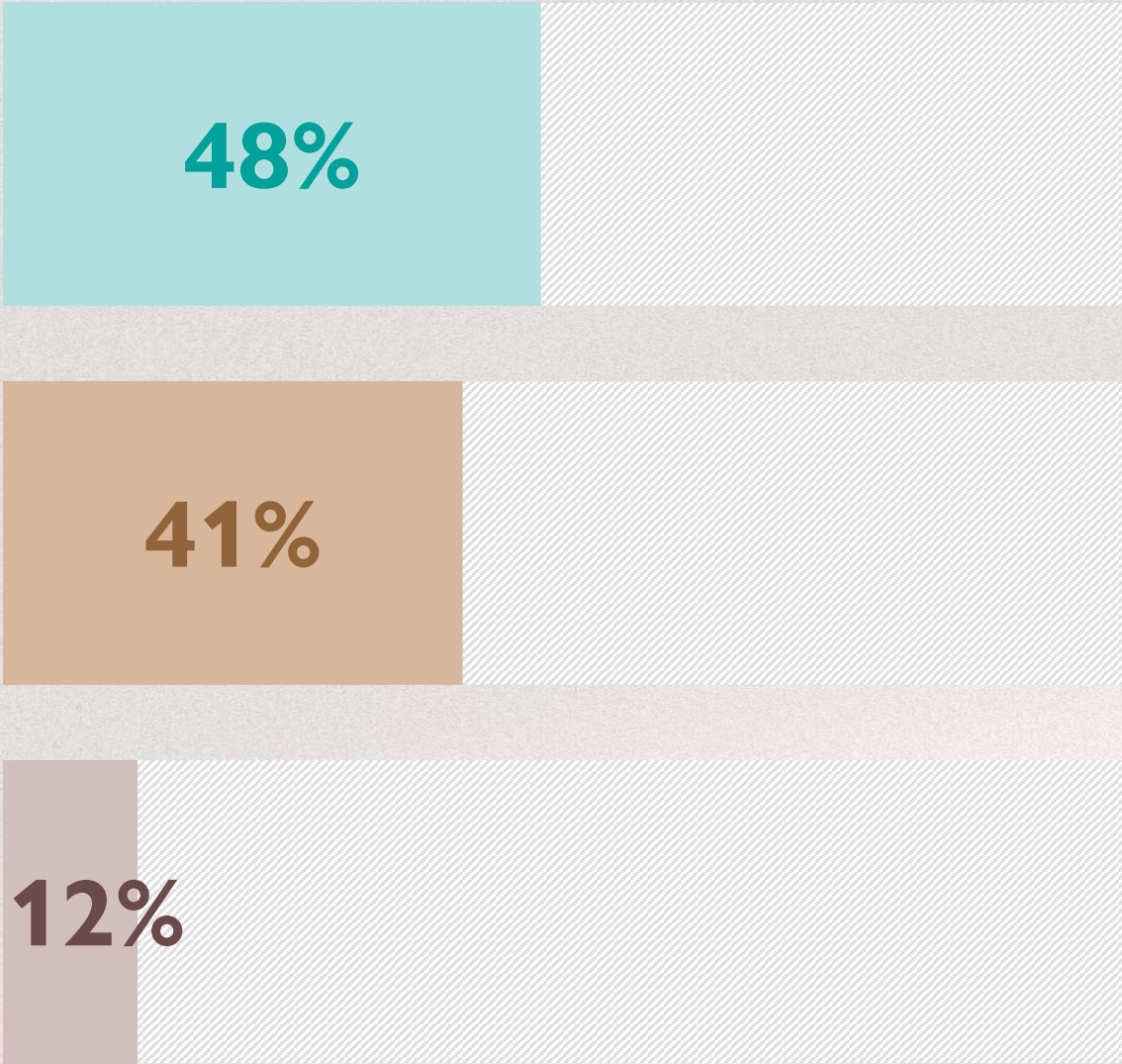

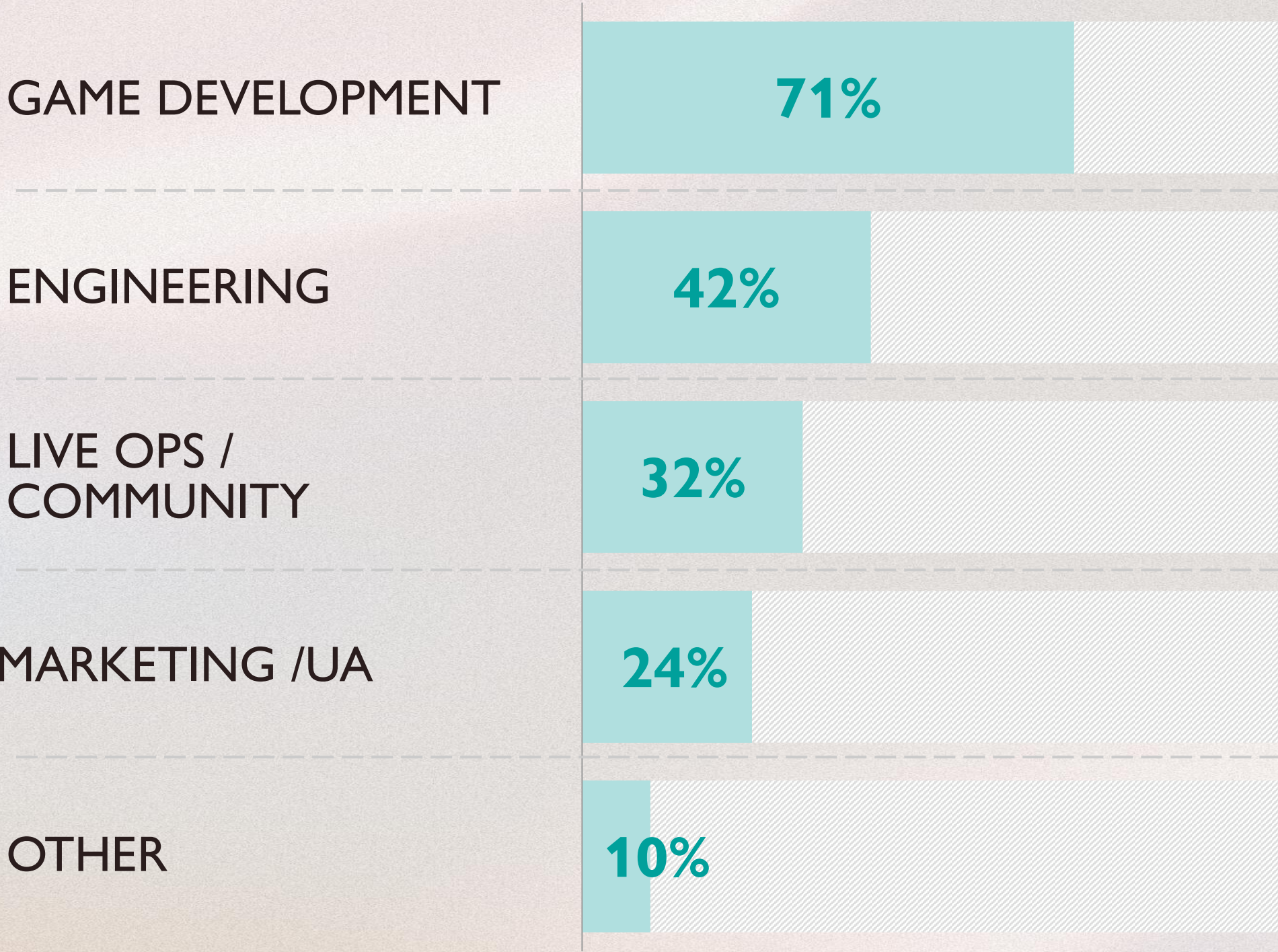

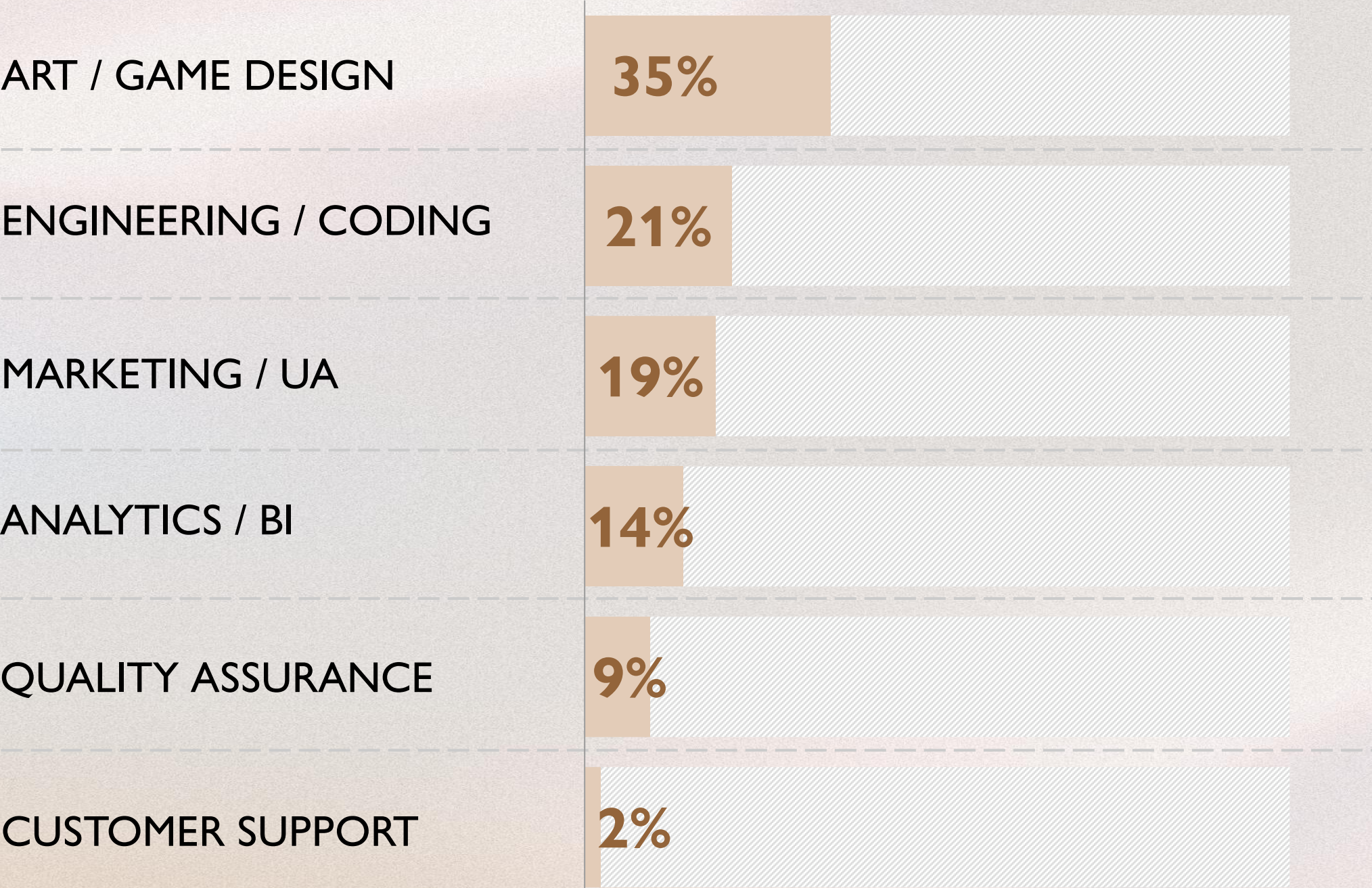

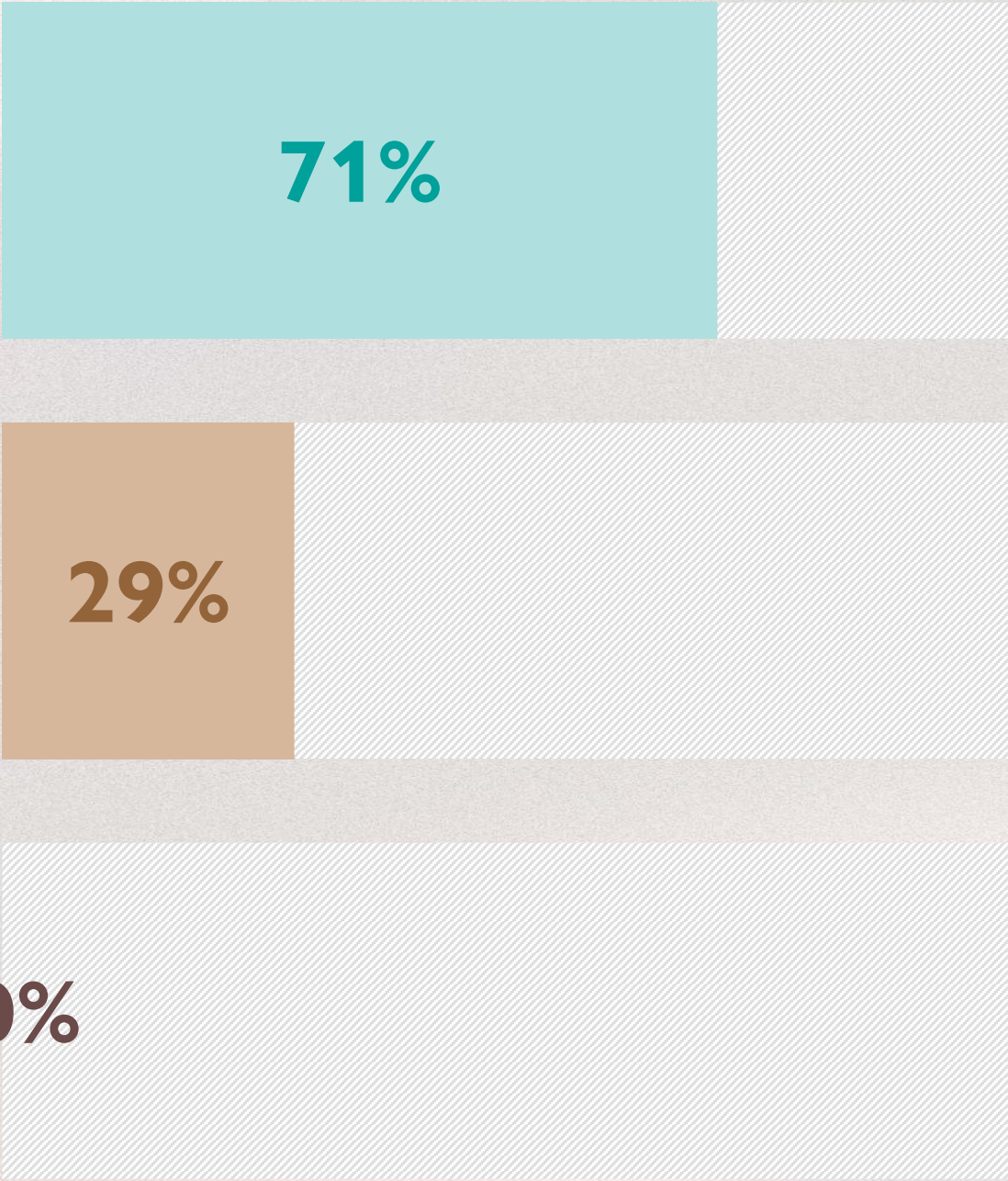
